



Versailles Income Tax Returns Due April 18th

Income Tax Administrator, Marie Rose, would like to remind all Versailles residents of the following tax filing requirements (18 years of age and older). **The 2016 Versailles income tax returns and payments are due on Tuesday, April 18th. Extensions do not extend the time you have to pay any tax due.**

Mandatory filing is required even if you did not work. Retired residents who have registered with the Tax Department are not required to file.

Anyone who resides in Versailles and did not receive a tax form can call the Tax Department at 526-3294, ext. 204 to request a form. Forms are also available at Worch Memorial Public Library and thru the Village website at www.versaillesohio.cc.

Tax Returns and Payments are due by April 18th. These can be mailed to Versailles Tax Department, PO Box 288, Versailles, OH 45380 or dropped off at the Tax Office located at 177 N. Center St.

Tax forms and payments can be dropped off at the Administrative Building or in the night deposit box located on the north side of the Administrative Building in the drive thru. Please refrain from folding large clasp envelopes and putting them in the night deposit box, as they will jam and not go through.

Versailles Shade Tree Commission Announces Annual Tree Lottery Program

The Versailles Shade Tree Commission has announced the Village will be accepting application request forms from eligible property owners for a chance at being randomly selected to receive one of fifteen trees that will be given away by the Shade Tree Commission as part of its annual Tree Lottery program. Property owners who received a tree through the 2016 Tree Lottery will not be eligible for the 2017 Tree Lottery.

The tree lottery trees are not limited to being planted within the public right-of-way. A property owner may opt to have the lottery tree planted upon their property outside the public right-of-way. All tree planting locations must be approved by the Village Shade Tree Commission.

Eligibility to participate in the lottery process is subject to certain criteria. Only owners of property located within the corporation limits will be eligible to participate in the lottery program. Tenants are ineligible to participate. If you own property within the Village and reside outside the Village, you are eligible to participate. Property owners with nonexistent or deteriorated sidewalks (as defined in the Sidewalk Installation/Replacement Ordinance) will be eligible to participate in the lottery program, but only will be permitted to have a lottery tree planted upon their property outside the street right-of-way.

Additional criteria includes property owners who fail to properly maintain either a replacement tree or lottery tree will not be eligible to participate in future lotteries; property owners will not be eligible to receive a tree through the lottery process in two consecutive years; property owners along a street that has been outlined in the Village's Five

Year Capital Improvements Plan for reconstruction will be eligible to receive a tree through the lottery process, but will only be permitted to have the lottery tree planted upon their property outside the street right-of-way; all lottery trees are subject to the Village's tree planting restrictions and will require a planting permit (there is no charge for the permit); and all decisions made by the Tree Commission are final.

Individuals interested in participating in the Tree Lottery program may obtain a form by stopping by the Administrative Office Building where they will be made available. Forms can also be accessed online and printed from the Village's website www.versaillesohio.cc under the Downloadable Forms - Miscellaneous Village Forms section. All forms for the year's upcoming lottery are to be returned to the Village Offices by Friday, March 30th. Village Reminds Residents and Contractors of Zoning/Building Permit & Inspection Requirements

With the spring season approaching, many residents and contractors will begin planning new construction projects. To assist in planning of these projects, there are several things individuals should know regarding the need for obtaining local permits.

Other than electric, water and sewer permits, the only type of construction-related permits issued by the Village are zoning permits. The issuance of a zoning permit certifies the proposed structure is in compliance with the use requirements (residential, commercial, or industrial), area requirements, and setback requirements in the affected zoning district.

In addition to zoning permits, persons performing construction, electrical, heating or cooling work, or re-roofing on residential properties in the Village are required to obtain a permit from the Darke County Building Regulations Office and have the necessary inspections conducted. Darke County Building Regulations now enforces the new 2013 Residential Building Code of Ohio and the 2011 National Electric Code of Ohio. If you are unsure if a permit is needed, visit the Darke County Building Regulations Office located in the County Administration Building at 520 South Broadway, Greenville, OH or call their office at 547-7379.

For structures involving industrial, commercial, institutional, multi-family, and mixed uses, State building permits must be obtained. State building permits can be applied for through the Miami County Building Regulations Office located at 510 West Water Street, Suite 120, Troy, Ohio. The telephone number for the Troy office is 937-440-8121.

Before finalizing any plans, it is a good idea to check things out thoroughly before you start. Although not enforced by Village Officials, some newer sections of the community have plat covenants which may prohibit or restrict the installation of fences, utility buildings, awnings, and other structures. These covenants can be enforced by any other property owner in the same development through civil court action.

Village Officials encourage individuals contemplating construction plans to check into the zoning and building permit regulations prior to beginning the project.
